LeBoeuf Township Supervisors Meeting – July 14, 2021

The LeBoeuf Township Supervisors meeting was held July 14, 2021. The meeting was called to order at 8:00 a.m. Present were James Glover, Michael Porter, Michael Whitman, Tim Pietrasewicz, Drew Francisco and Catherine Wise.

Michael Porter motioned to approve the minutes from the June 23, 2021, Regular Meeting. Michael Whitman seconded. All voted yes.

James Glover moved to submit for audit the Treasurer's Reports for July 15, 2021– General Fund: \$41,654.56 and State Fund: \$73,023.45. Health Reimbursement Fund: \$1,635.34. Michael Whitman seconded. Motion carried.

Discussion was held on Armstrong E-mail response on a per mile cost for expansion of Broadband within LeBoeuf Township. Armstrong has no estimated cost, at this time. Supervisors would like to know when or if Armstrong plans on expanding within the township. Federal money is available to expand broadband in rural communities.

The Erie County Fair program has a purchase of bricks program to raise funds. Supervisors opted out of purchasing a brick.

The Public Hearing for Ordinance #1 of 2021 – Amendments to the Zoning Ordinance will be advertised for July 28, 2021, at 6:00 p.m. to be held before the Regular meeting of the LeBoeuf Township Supervisors.

Road Foreman Report: Drew Francisco reported that Wilkinson Excavating has finished crushing and screening at the Mystic Road Gravel pit. More millings have been stockpiled at the Gravel pit for future use. The Road crew has been hauling anti-skid for Washington Township in exchange for help with the road project on Old Meadville Road. Cross-pipes were placed on Stone Quarry Road. The generator was used for the Red Light at Route 6 & 19, during outages. Trees were cleaned up after recent storms. There will be a bridge inspection of Dewey Road within the week. Tabled.

Zoning Officer Tim Pietrasewicz reported on the property located at 12936 McGahen Hill Road. A letter was sent asking the property owner to clean up the property. There has still been nothing done. The Rainbow Farm on Old Route 19 is cleaning up their property. The fence on the property on Camp Mystic Road will need removed by the end of August. Blaine Melnick received a permit for an addition.

Correspondence was read & reviewed.

Michael Whitman motioned to ratify Bills & Payroll for July 1, 2021. James Glover seconded. All voted yes.

James Glover motioned to sign Bills & Payroll for July 15, 2021. Michael Whitman seconded. All voted yes.

Michael Porter moved, seconded by James Michael Whitman, to adjourn the regular meeting at 8:36 a.m. Motion carried unanimously.
