

LeBoeuf Township Supervisors Meeting – October 23, 2024

The LeBoeuf Township Supervisor's Meeting was held on October 23, 2024. The meeting was called to order at 6:00 p.m. Present were William Phillips, James Glover, Michael Porter, Ginger Bollinger, Brad Francisco, Pat & Darlene Laughery, Tim Pietrasewicz and Catherine Wise.

Michael Porter motioned to approve the October 9, 2024, Regular Meeting Minutes. William Phillips seconded. All voted yes.

James Glover moved to submit for audit the Treasurer's Report for October 17, 2024– General Fund: \$64,701.22, State Fund: \$20,227.30. Health Reimbursement Fund: \$2,941.97, Capital Reserve Fund: \$24,987.78. William Phillips seconded. Motion carried.

Vicent Road Resident Brad Francisco was present to discuss the Ploss Property on Vincent Road. He stated that they still have not cleaned up the property. The complaint is about high grass and junk on the property. Solicitor Gery Nietupski will be contacted – the LeBoeuf Township Supervisors stated that it may be time to take Mr. Ploss to Court for non-compliance of the Property Ordinance.

Pat & Darlene Laughery are planning on building a Barndiminium on 10 acres of property on Sturgis Road. They had questions concerning Subdividing and Driveway Permits (State Road). They are working on an in-ground septic system with a 10-acre exemption, with the Erie County Health Department. They left the meeting at 6:18 p.m.

Supervisors voted to cancel the November 27, 2024, Supervisors meeting, due to Thanksgiving Holiday Week. This will be advertised.

PennDOT sent a letter concerning the Rockdale Road Bridge Replacement slated for 2025. Traffic will be detoured onto a small section of Old Meadville Road for the duration of the project.

Michael Porter motioned to sign the ASA letter stating that the Troyer's may join the Waterford Township ASA, until an ASA Program can be established in LeBoeuf Township.

Road Forman Report: The Road Crew has been pulling shoulders and grading on the following roads: Mystic, Conneauttee, Old Meadville, Gorman and Old Plank Roads. They extended a drainage pipe on Gorman Road. The Grant for the Grader will be re-applied for, due to the fact it was not granted in the first round.

Zoning Officer: The Variance Hearing for Mr. Litz was held on October 22, 2024, the Zoning Hearing Board stated that the sign will be labeled as a Billboard and may only be up to 100 square feet.

Discussion was held on Mr Oberath. Solicitor Gery Nietupski will be asked to send him a letter concerning a woodshed within the road right of way at Henry Road and Route 6.

Correspondence was read and reviewed.

Michael Porter motioned to Ratify Bills & Payroll for October 17, 2024, William Phillips seconded. All voted yes.

Michael Porter moved, seconded by William Phillips, to adjourn the regular meeting at 6:40 p.m. Motion carried unanimously
