

LeBoeuf Township Supervisors Meeting – November 13, 2024

The LeBoeuf Township Supervisor's Meeting was held on November 13, 2024. The meeting was called to order at 8:00 a.m. Present were William Phillips, James Glover, Michael Porter, Tim Pietrasewicz and Catherine Wise.

James Glover motioned to approve the October 23, 2024, Regular Meeting Minutes. Michael Porter seconded. All voted yes.

James Glover moved to submit for audit the Treasurer's Report for November 14, 2024– General Fund: \$71,727.75, State Fund: \$5561.05. Health Reimbursement Fund: \$2,942.00, Capital Reserve Fund: \$24,987.98. William Phillips seconded. Motion carried.

William Phillips motioned to authorize James Glover to sign the 2025 Dog License Agreement to be submitted to Erie County. Michael Porter seconded the motion. All voted yes.

Michael Porter motioned to sign Resolution #7 of 2024 – The Tax Enactment Resolution for 2025 Taxes, with the addition of a .5 tax increase to establish 2025 millage at 2.0 mills. William Phillips seconded the motion to raise taxes and to enact Resolution #7 of 2024. All voted yes. Motion carried.

There will be a County Council Budget meeting on Tuesday, November 19, 2024, at the County Courthouse. William Phillips plans on attending to represent LeBoeuf Township. LeBoeuf Township has asked for a grant for road drainage. Discussion was held on Tar & Chip for Stone Quarry in 2025 or 2026. Dependent on Grants and drainage. Tabled.

Supervisors stated that they are not interested in purchasing first-aid kits from CINTAS.

Mr. Hull sent an Email addressing Moore Road. Supervisors reviewed his comments.

LeBoeuf Township will receive a Dirt & Gravel Road Grant for Stone Quarry Road to address drainage at the East end.

Road Forman Report: The Road Crew has been spot-grading. 1 truck is ready to start plowing. The mower tractor is torn apart and being fixed. A few Stop Signs have been fixed or replaced. Supervisors discussed placing/replacing stop signs on Old Route 19 South.

Zoning Officer: 1 permit and 1 Occupancy Permit for a Business were submitted.

Correspondence was read and reviewed.

William Phillips motioned to Ratify Bills & Payroll for October 31, 2024, James Glover seconded. All voted yes. Michael Porter motioned to Sign Bills & Payroll for November 14, 2024, William Phillips seconded. All voted yes

William Phillips moved, seconded by James Glover, to adjourn the regular meeting at 9:03 a.m. Motion carried unanimously
